You understand and agree that GIA India is not obligated to use, display, reproduce, or distribute any such ideas, know-how, concepts, or techniques contained in the Feedback, and you have no right to compel such use, display, reproduction, or distribution.

## 17. Dispute Resolution and Arbitration; Class Action Waiver.

## Please read this carefully. It affects your rights.

Most user concerns can be resolved quickly and to a user's satisfaction by contacting us via a notice sent to Legal Department, GIA India Laboratory Private Limited, 10th Floor, Trade Centre, Bandra Kurla Complex, Bandra East, Mumbai, Maharashtra 400098. This Dispute Resolution and Arbitration; ("Provision") facilitates the prompt and efficient resolution of any disputes that may arise between you and GIA India. Arbitration is a form of private dispute resolution in which persons with a dispute waive their rights to approach courts and instead submit their disputes to a neutral third person (or arbitrator) for a binding decision.

The term "Dispute" means any dispute, claim, or controversy between you and GIA INDIA regarding any aspect of your relationship with GIA INDIA, whether based in contract, statute, regulation, ordinance, tort (including, but not limited to, fraud, misrepresentation, fraudulent inducement, or negligence), or any other legal or equitable theory, and includes the validity, enforceability or scope of this Provision. "Dispute" is to be given the broadest possible meaning that will be enforced, and shall include any claims against other parties relating to services or products provided or billed to you (such as GIA INDIA's licensors, suppliers, dealers or third-party vendors) whenever you also assert claims against us in the same proceeding.

WE EACH AGREE THAT, EXCEPT AS PROVIDED BELOW, ANY AND ALL DISPUTES, AS DEFINED ABOVE, WHETHER PRESENTLY IN EXISTENCE OR BASED ON ACTS OR OMISSIONS IN THE PAST OR IN THE FUTURE, WILL BE RESOLVED EXCLUSIVELY AND FINALLY BY BINDING ARBITRATION RATHER THAN IN COURT IN ACCORDANCE WITH THIS PROVISION.

**Pre-Arbitration Claim Resolution** 

For all Disputes, whether pursued in court or arbitration, you must first give GIA INDIA an opportunity to resolve the Dispute. You must commence this process by mailing written notification to India. That written notification must include (1) your name, (2) your address, (3) a written description of your Claim, and (4) a description of the specific relief you seek. If GIA India does not resolve the Dispute within 45 days after it receives your written notification, you may pursue your Dispute in arbitration. You may pursue your Dispute in a court only under the circumstances permitted by the Arbitration and Conciliation Act, 1996 as amended from time to time ("Arbitration Act").

## **Arbitration Procedures**

If this Provision applies and the Dispute is not resolved as provided above (Pre-Arbitration Claim Resolution) either you or GIA INDIA may initiate arbitration proceedings in accordance with the Arbitration Act. The arbitration proceedings shall be conducted before a sole arbitrator mutually appointed or appointed in accordance with the Arbitration Act. The language of arbitration shall be English.

Location of Arbitration – You or GIA India may initiate arbitration in Mumbai, India

Payment of Arbitration Fees and Costs –Fees and costs shall be decided by the arbitrator and may be awarded as provided pursuant to applicable law. In addition to any rights to recover fees and costs under applicable law, if you provide notice and negotiate in good faith with GIA INDIA as provided in the section above titled "Pre-Arbitration Claim Resolution" and the arbitrator concludes that you are the prevailing party in the arbitration, you will be entitled to recover reasonable attorney's fees and costs as determined by the arbitrator.

Arbitration Award – The arbitrator may award on an individual basis any relief that would be available pursuant to applicable law and will not have the power to award relief to, against or for the benefit of any person who is not a party to the proceeding. The arbitrator will make any award in writing but need not provide statement of reasons unless requested by a party. Such award will be final and binding on the parties, except for any right of appeal provided by the Arbitration Act and may be entered in any court having jurisdiction over the parties for purposes of enforcement.

## 18. Governing Law

Subject to the dispute resolution and arbitration Provisions stated above, any disputes arising in relation to this Agreement shall be governed by the laws of India and courts of Mumbai shall have exclusive jurisdiction.

### 19. Relationship

None of the provisions of the Terms shall be deemed to constitute a partnership or agency between you and GIA India and you shall have no authority to bind GIA India in any manner, whatsoever.

## 20. Severability

If any provision (or portion thereof) of the Terms shall be held by a court of competent jurisdiction to be invalid, void, or otherwise unenforceable, the remaining provisions shall remain enforceable to the fullest extent possible and permitted by law.

#### 21. Waiver

No Terms shall be considered waived by GIA India unless such waiver is in writing. No consent or waiver of a breach, whether express or implied by GIA India, will constitute a consent to, waiver of, or excuse of any other, different, or subsequent breach.

### 22. General.

GIA India prefers to advise you if we feel you are not complying with these Terms and to recommend any necessary corrective action. However, certain violations of these Terms, as determined by GIA India, may result in immediate termination of your access to this Site without prior notice to you. Rights and obligations under the Terms which by their nature should survive will remain in full effect after termination or expiration of the Terms. If any of these Terms is found to be inconsistent with applicable law, then such term shall be interpreted to reflect the intentions of the parties, and no other terms will be modified. GIA India's failure to enforce any of these Terms is not a waiver of such term. These Terms are the entire agreement between you and GIA India regarding the use of the Site and supersede all prior or contemporaneous negotiations, discussions or agreements between you and GIA India about this Site. The proprietary rights, disclaimer of warranties, representations made by you, indemnities, limitations of liability and general provisions shall survive any termination of these Terms.
