### PEARL SERVICES

GIA Pearl Services provide information on the identity of pearls (natural or cultured), the mollusk (when determinable) they originated from and the environment they formed in (saltwater or freshwater), and also state whether the pearls have undergone treatment, as well as providing classification information based on the GIA 7 Pearl Value Factors, depending on the service type chosen.

### PEARL IDENTIFICATION REPORTS

Details the quantity, weight, size, shape, color, overtone, identity, mollusk (when determinable), environment and any detectable treatments. Report includes a digital image.
